Welcome and introductions - James

Review/update on any previous actions – James

- Carole/Pete's previous suggestion about a social element to meetings is taking place in the form of in person mince pies/coffee at the next PPG meeting (11th December) which will be promoted to all patients on the website, social media and through flyers patients can be given. The formal PPG meeting can take place beforehand with a drop-in style hour session where patients could find out more about how our surgeries work, ask non-clinical questions etc.
- Note about next meeting: the next PPG meeting on 11th Dec and will be in person at Wilton (Old Orchard Surgery, South Street, Wilton).
- Writing sensitive matters down on paper at reception when a patient is making an enquiry has worked well in the pilot at Wilton, although not used often it may be helpful for some patients. James will print more sheets for reception desks at all sites. We don't anticipate it will be widely used but may help support some patients in a caring and compassionate way if they have something confidential to discuss. It was previously raised about the possibility of having side rooms for patients if conversations were of a sensitive nature, but unfortunately the physical spaces don't allow this at any site. Staff are aware of the need to maintain confidentiality and are



reminded of the need to be aware of conversations being audible by others in waiting rooms.

Any key messages from TOP practice management – James:

- Flu and Covid jabs have been very busy, and uptake has been very strong. It has been a challenge for the clinical and non-clinical teams however due to strong demand and limited capacity, so this will be reviewed and fed back to the PCN.
- Pauline and Carole offered to help at the clinic, but due to the different operational setup this year (different to previous years which were run as hubs by the PCN), this help wasn't necessary at present – however it was noted and appreciated that this volunteer resource might be beneficial for future years. Thank you.

NHS "Friends and Family test" feedback - James

• Consistently high scores being received, which is encouraging. There are occasional complaints that are handled promptly, and every complaint or piece of feedback is appropriately and thoroughly investigated.
